Policies on Kyoto University Division of Graduate Studies DoGS Next AI Program in application for tuition exemption in the second semester for AY 2024-2025

ODoctoral students in DoGS Next AI program for AY 2024-2025 (Excluding

those who have an offer of the program for the following academic year)

Starting from AY2024-2025, all doctoral students in DoGS Next AI program are to be granted full tuition exemption under "Rules to establish special provisions on tuition exemption in support programs for doctoral students with excellent academic performance at Kyoto University".

No application is required regarding this measure.

However, in the event of cancellation of payment for the above program (loss of eligibility, withdrawal, etc.), tuition fees from the month of revocation will not be exempt.

OStudents applying to DoGS Next AI program Fall Selection AY2024

Students who applied to DoGS Next Al program Fall Selection AY2024 who seek exemption from tuition fees <u>must complete all application procedures (Step 1 and Step 2) for the university's tuition exemption for the second semester of AY2024-2025 within the stipulated period.</u>

If you wish to apply as a self-financed student, ensure to exclude the grant of DoGS Next Al program from your income in case you are not selected for the program. Furthermore, please write "Applied for DoGS Next Al Program" in the comment field on the back of submission envelope.

Tuition payment in case of a fail at NEXT Al program (if you have applied for the university's tuition exemption, the amount is subject to the exemption results) is scheduled around mid February regardless of whether you have applied for tuition exemption.

OStudents to withdraw from DoGS Next AI program and lose its status during the second semester of AY2024

If you withdraw from the program, you will be responsible for the remaining tuition fees from the month of revocation.

Hence, please apply for the university's tuition exemption for the second semester of AY2024-2025 if you wish to be exempt from paying tuition fees.

In Step 2, submit necessary documents enclosed in the designated envelope with "Withdrawal from DoGS Next Al Program expected in [month]" remarked in comment field on the back of the envelope.

The remaining tuition from the month of revocation will be exempt according to the application results for the university's tuition exemption.

OStudents enrolled in fall semester AY2024 who wish to apply for admission fee exemption/ deferment

Full exemption provided to DoGS Next AI program recipients only applies to tuition fees. Therefore, students enrolled in fall semester AY2024 who wish to request exemption from admission fees and permission to defer its payment must apply for the university's admission fee exemption/ deferment.
